4. Selection of the candidates will only be based on prescribed qualification, experience and performance in test/interview as per the Circular No : NHM/4827/ADMN1/ 2019/SPMSU dated 28.10.2019
5. The successful candidate will have to enter into a contract with District Health and Family Welfare Society (Arogyakeralam) Thiruvananthapuram District.
6. The successful candidates will be appointed on contract basis initially for a period of

three months only. The District Health & Family Welfare Society (Arogyakeralam) may at its discretion, based on the performance and integrity of the successful candidate, may extend the period of contract.
