The above homoeo doctors shall be under the administrative control of the District Medical Officer (homoeo) of the district concerned. They are entitled to get a monthly consolidated remuneration of Rs.26,000/- (Rupees twenty six thousand only) and no other allowances are admissible to them. Remuneration based on attendance certificate, signed by the District Medical officer (homoeo), shall be released by the District Programme Manager , concerned.

Dear Candidate,

1. Consequent on your selection made by the selection board, you are hereby Offered the post of **Medical Officer (Homoeo)** in the Temporary Grama Panchayath Homoeo Dispensary, Udumpanchola/ Senapathy/ Kanthalloor/Chunakkara/ Nedumudi/ Vayalar/ Budhanur/ Kayakkodi under the District Health & Family Welfare Society, Idukki/ Alappuzha/ Kozhikode on contract basis initially for a period of three months at a consolidated remuneration Rs.26,000/- per month.
2. The terms of your appointment will be as given in the *Terms of Contract* document (**Form-I**) which you have to download (given in NRHM website www.arogyakeralam.gov.in) and sign in stamp paper worth Rs.100/- at the time of joining your duties under the Society.
3. Other conditions of your service under the Society will be governed by such rules as may be adopted by the Society from time to time.
4. Please note that your appointment is also subject to:
 - i) Production of a certificate of fitness from the Competent Medical Authority viz. Civil Surgeon in the prescribed form (**Form-II**).
 - ii) Submission of declaration in the prescribed form (**Form-III**). In the event of a candidate having more than one spouse living or being married to a person having more than one spouse living, the appointment will be subject to his/her being exempted from the enforcement of the general rule in this behalf.
 - iii) Taking of an oath of allegiance/ faithfulness to the Constitution of India (Or making of a solemn affirmation to the effect) in the prescribed form (**Form-IV**).
- iv. Production of the original certificates:
 - a. Certificate of educational and other technical qualifications.
 - b. Certificate of age.
 - c. Character certificate in the prescribed form (**Form-V**) from the Head of Educational Institution last attended by him/her or a similar certificate from his/her present employer.
 - d. Discharge certificates in the prescribed form from previous employer, if any.
5. If any declaration given or information furnished by you proves to be false or if you are found to have willfully suppressed any material/ information, you will be liable to removal from the said post under the Society and such other action as the Society may deem necessary.
6. Please communicate your acceptance or otherwise to the undersigned immediately within 02 days on receipt of this Offer Letter and thereafter appear before the competent medical authority/District Medical Officer (Homoeo) Thiruvananthapuram along with the necessary documents with in fifteen days on receipt of the order. You will be under the administrative control of the District Medical Officer (Homoeo). Your remuneration based on the attendance certificate signed by the DMO (Homoeo) will be released by the District Programme Manager (NRHM).

7. If you fail to join your duties by the above stipulated date, the offer of appointment made to you is liable to be treated as cancelled forthwith.

8. No travelling allowance will be allowed to join the appointment.
