As per the Government Order read as 1st paper above thirteen temporary siddha dispensaries have been sanctioned in various Grama Panchayaths. Dear Candidate,

1. Consequent on your selection made by the selection board, you are hereby offered the post of Medical officer, Siddha in the Temporary Grama Panchayath Dispensary, Parassala/ Kanjiramkulam/ Thuravur/ Veliyanad/ Ramankari/ Vayalar/Perumbalam/ Valenchery/ Vandiperiyar/ Kumily/ Kizhakkoth under the District Health and Family Welfare Society, Thiruvananthapuram/ Kollam/ Alappuzha/ Idukki/ Malappuram/kozhikode, on contract basis for a period of three months on a consolidated remuneration of Rs.26,000/- per month.
2. The terms of your appointment will be as given in the Terms of contract document (Form-1) which you have to down load (given in NRHM website www.aogyakeralam.govt.in) and sign in stamp paper worth Rs.100/- at the time of joining your duties in the Society.
3. Other conditions of your service under the society will be governed by such rules as may be adopted by the Society from time to time.
4. Please note that your appointment is also subject to:
 - i. Production of a certificate of fitness from the competent medical authority viz.Civil Surgeon in the prescribed form (Form ii)
 - ii. Submission of declaration in the prescribed form (Form iii). In the event of a candidate having more than one spouse living or being married to a person having more than one spouse living, the appointment will be subject to his/her being exempted from the enforcement of the general rule on this behalf.
 - iii. Taking of an oath of allegiance/faithfulness to the constitution of India (or making of a solemn of affirmation to the effect) in the prescribed form (Form-iv).
 - iv. Production of the original certificates:
 - a. Certificate of educational and other technical qualifications.
 - b. Certificate of age.
 - c. Character Certificate in the prescribed form (Form v) from the head of educational institution last attended by him/her or a similar certificate from him/her present employer.
 - d. Discharge Certificate in the prescribed form from previous employer, if any.
5. If any declaration given or information furnished by you proves to be false or if you are found to have willfully suppressed any material/information you will be liable to removal from the said post under the Society and such other action as the Society may deem necessary. Please communicate your acceptance or otherwise to the undersigned immediately with in two days on receipt of this offer letter and thereafter appear before the competent medical authority /District Medical Officer,(ISM). Your remuneration based on the attendance certificate signed by the District Medical Officer (ISM) will be released by the District Programme Manager, NRHM. If you fail to join your duties by the above stipulated date the offer of appointment made to you is liable to be treated as cancelled forthwith.
