4	The selected candidate should be willing to travel anywhere in the State.
5	The applicants should be excellent in writing skills both in English and Malayalam and should be proficient in computers.
6	Selection will be based on qualification and experience in the event of there being more than one eligible applicant, an interview will be conducted.
7	The successful candidates will be appointed on contract initially for a period of one year. Based on the performance of the successful candidate, Government may extend the period of contract.
