ORDER

The Director of Health Services, Thiruvananthapuram in his letter read as 2<sup>nd</sup> paper above has reported that the executive committee of State Health & Family Welfare Society has decided to procure furniture and other equipments for E.K.Nayanar Memorial Government Women & Children Hospital, Mangattuparamba, Kannur with National Rural Health Mission (NRHM) funds in the eve of inauguration of IP facility with Operation Theatre and Neo Natal Intensive Care Unit. The State Mission Director, National Rural Health Mission, Thiruvananthapuram vide proceeding order read as 1st paper above has also issued Administrative Sanction for an amount of Rs. 34,85, 000/- (Rupees Thirty Four lakh Eighty Five Thousand only) for procurement and supply of equipments for the hospital. The Director of Health Services has also informed that there is no sufficient time to go for Open Tender as the inauguration of the IP facility in the hospital is scheduled to be conducted on the second week of July 2010. In view of the urgency the Director of Health Services has requested to accord sanction to invite Limited Tender for the purchase of equipments.

2. Government have examined the matter in detail and are pleased to accord sanction to the Director of Health Services, for inviting Limited Tenders for purchasing the equipments as per provision in para 17 (ii) of Store Purchase Manual

and also observing all other formalities as per provisions in Store Purchase Manual in which Administrative Sanction was issued by the State Mission Director, National Rural Health Mission.
