ORDER

In the budget estimate for 2010-11 an amount of Rs. 400 lakh has been provided under the head of account 2210-03-110-98 for 'Standardisation of facilities in District, Taluk and General Hospitals' which are functioning at different levels of infra structure facilities, equipment levels with different staff strength. Due to the implementation of speciality cadre, speciality departments of these hospitals are to be well equipped on par with the Indian Public Health standards. The outlay provided is proposed for equipping these hospital in tune with the latest development in Medical Technology.

2) As per the letter read above, the Director of Health Services has submitted proposal seeking Administrative Sanction for the purchase of certain equipments at a total cost of Rs. 346.25 lakh to strengthen surgery, Orthopaedic, ENT, Gynaecology, Respiratory medicine Departments of District, Taluk and General Hospital and other Speciality hospitals as per Indian Public Health Standards.

3) The Special Working Group held on 24.06.2010 chaired by the Additional Chief Secretary (Finance) considered the proposal for implementation during 2010-11 and has agreed to accord Administrative Sanction for the purchase of the equipments, vide the minutes read above.

4) In pursuance of the decision of the Special Working Group, Administrative Sanction is accorded to procure the equipments at a total cost of Rs. 346.25 lakh as detailed below to equip and strengthen those hospitals towards standardising the facilities on par with Indian Public Health standard, subject to observance of Stores Purchase Rules.
