**ORDER NO. FW(SPL-CELL) 61647/07/DHS DATED: 10/08/2009**

A preliminary gradation list as on 31-12-2006 (21-01-1994 to 31-12-2006) was published as per ref cited subject to the provisions of appeals. On verification of appeals preferred in the list, it is found that several persons were omitted due to incomplete district wise seniority list, which have been verified. All appeals have been examined in detail and necessary corrections / additions made in accordance with existing rules.

The Criteria observed for preparation of this State Seniority list are:-

1. This list is prepared exclusively on the basis of the district seniority list and Government directions in view of Court orders for regular appointment.
2. The Seniority of those incumbents who have secured appointment for more than one District in the same categories will be counted with effect from the last appointment ( New PSC Appointment) as the case maybe.
3. Those who are not included in the ratio based promotion list of JPHN Gr-1 as per order 1<sup>st</sup> cited, as they left from the original district they appointed, are considered in this list.
4. On verification of the District wise seniority list so many JPHNs are seen included in the list eventhough they possess the followings :-

- a. Obtained appointments in various districts in the same category; still even after the declaration of probation
- b. Inter District Transferee without any change in the cadre

These cases are reviewed and included in this seniority list with effect from the actual date / advice / G.O of the last appointment.

5. Nothing will affect adversely at the time of retrospective effect of promotion in the cadre of JPHN Gr-I to those who are in low ranking due to inter district transfer, and if they acquire eligibility for promotion at the previous district. This benefit is not allowable to those who obtained PSC appointment in more than one district.

A final seniority list of JPHNs as on 31-12-2006 is prepared and appended to this order for information of all concerned. Any omissions / corrections occurred in this lists should be brought to the notice of the under signed and got corrected accordingly. All District medical Officers are requested to circulate this for information of all concerned without fail.
