#### HIRING OF A/C TOURIST CARS

# FOR OFFICIAL USE ON CONTRACT BASIS UNDER STATE PROGRAMME MANAGEMENT & SUPPORT UNIT (AROGYAKERALAM)

Sealed competitive tenders are invited in hiring of A/C cars based on three categories (as detailed below) for official use, on contract basis, under the following terms and conditions:

#### Pre Qualification conditions

- First Registration of the vehicle offered should be on or after 1/12/2011.
- The bidder should have a fleet of at least 10 vehicles under his control in all the three categories of vehicles put together as required by NRHM.
- Copies of IT returns filed for the last 3 years are to be submitted while submitting the
  pre bid documents. Non submission will be liable for outright rejection of tender. (For
  the Assessment year 2011-12,2012-13 and 2013-14)

#### Other Conditions

- The vehicles will have to run distance as required.
- 2. The vehicles will have to run as specified.
- 3. The vehicles along with driver should be provided on 24 X 7 basis upon request
- All the maintenance for the vehicles will have to be done by the contractor
- (a) The rates for each vehicle contracted on monthly basis as well as daily basis (for occasional use) may be quoted separately.
  - (b) The rates of each category of vehicles contracted for transfer of guests between city hotels to Railway station, City Hotels to Airport, Hotels at Kovalam Railway Station and Hotels at Kovalam to Airport may also be guoted separately.
- Fuel for the vehicle will be provided by the contractor.
- The initial contract shall be signed for 11 months which can be extended for a further period of 11 months based on reliability and performance.
- 8. A vehicle may run an average of 1500 KM per month/ 300 Hours
- Drivers for out station duties will have to make their own arrangements for stay.
- NRHM reserves the right to terminate the deal without any notice.

#### CONDITIONS FOR MONTHLY CONTRACT OF VEHICLES

- The vehicles should be parked at NRHM Directorate Campus on all days.
- The rates quoted should include wages to the Driver, fuel charges, maintenance charges, Insurance and any other charges and for providing vehicle in a good running condition.
- 3. In case of non-availability of vehicles on demand at any time, Penalty per day is liable

to be imposed at an amount equivalent to the rates approved for concerned category on daily basis.

4. In case of non provision of vehicle continuously for a period, more than one week, it shall be treated as breach of contract, and the EMD shall be forfeited. <u>EMD is also liable to be forfeited if the contractor is not prepared to provide the vehicle after awarding the contract to him.</u>

- 5. Tender is to be accompanied with an EMD of Rs.2000/- for each category (Rupees two thousand only) i.e., Rs. 6,000/- for all the three categories put together by way of demand draft (in favour of State Health & Family Welfare Society) with the State Health & Family Welfare Society, National Rural Health Mission, Directorate of Health Service, NRHM Building, Thiruvananthapuram-695035. Tender without EMD will be summarily rejected. EMD remitted will be forfeited if the bidders withdraw from the tender or fail to carry out the work, after work is awarded. EMD of unsuccessful will be returned after the tender is finalised.
- An amount of Rs. 5000/- is to be remitted as security deposit by the successful bidder, for each category vehicle for which agreement is signed/contract awarded. The EMD amount can be utilised to the extent possible towards Security Deposit requirement. This amount will be returned only after satisfactory completion of contract period.

### GENERAL CONDITIONS

1. The price bids of only those Pre Qualified bidders will be OPENED.

The Contractor shall provide and keep the vehicles in good running condition and shall ensure that all road taxes, insurance etc. are paid in time and borne by him. The vehicles, when contracted, will be kept at the disposal of the NRHM. If and when the driver is not available a replacement shall be provided by the Contractor.

3. Whenever the vehicle is taken out for servicing, repairs etc., an alternate vehicle of the similar make will have to be provided by the contractor at his own cost within a reasonable time. In the case of an accident while the car is being driven by the Contractor's driver, all repairs shall be done by the Contractor without any liability to NRHM or its employees. In case, due to some breakdown, the vehicle is not available, the contractor shall make arrangements to provide alternate vehicle at his own cost, within a reasonable time.

4. Rates, terms and conditions of contract quoted, once accepted by NRHM shall not be altered during the currency of the contract (normally eleven months) for any reason and shall be valid till the expiry of contract, for eleven months from the date of award. There shall not be any price increase in the rates quoted during the currency of the contract. The contract can be terminated by giving a notice of one month on either side.

5. The log books shall be kept in the safe custody of the Driver, who shall get the same filled up and authenticated at the end of each lap of journey undertaken by the officials of NRHM. The log book shall be made over to the authority passing the bill. The log book shall be submitted along with the bill to the Controlling Officer.

The contract will be normally for eleven months from the date on which the vehicle start
plying and the bidders should execute an agreement with NRHM to that effect in a
stamped paper worth Rs.100/-.

7. The Driver shall have to wear white shirt, white pants, with black shoes. He should be well dressed, well behaved and professionally skilled to drive any make of vehicle. Any laxity of the behaviour of the Drivers shall be treated as breach of contract resulting in cancellation of contract and forfeiture of EMD.

The tender should be sent in sealed envelope only, and should CONTAIN two
covers separately inside the main envelope viz., -one containing
PREQUALIFICATION DOCUMENTS and other containing PRICE BID. The
cover which contains pre qualification documents should be sealed and
superscribed "PRE QUALIFICATION DOCUMENTS". Similarly envelope

containing the price bid should be sealed and super scribed "PRICE BID". Both these ENVELOPES SHOULD BE PLACED IN THE MAIN ENVELOPE which should be sealed and super scribed "TENDER FOR HIRING OF VEHICLES" and should be addressed to State Mission Director (NRHM), NRHM Building, Directorate of Health Services, General Hospital Junction, Thiruvananthapuram - 695035 so as to reach SMD not later than 17.00 hrs on 27th January 2014. The pre qualification bids will be opened at 3.00 pm on 28th January 2014 and the Price Bid will be opened at 11.00 AM on 29th January 2014 in the presence of those bidders who are present.

The rate should be quoted in the enclosed proforma.

 No advance will be made and the payment will be made only on a monthly basis on presentation of bill after deducting statutory recoveries.

11. If the services of the contractor are not satisfactory, NRHM reserves the right to cancel

the contract at any point of time without giving any reasons thereof.

12. In case of non- availability of the vehicles on any day the expenses incurred by this office in this regard for making alternate arrangements, will be deducted from the contractor from his monthly hire charges payable to him by the company/from his security deposit.

13. In case of non-provision of vehicle continuously for a period of more than three days or failure to attend repairs and replacement promptly to our satisfaction, it shall be treated as breach of contract, and the Security Deposit shall be forfeited and contract

may not be continued any further.

 Terms and conditions of contract quoted and accepted by the State Program Monitoring Support Unit shall not be altered during the contract period.

15. The contract may be awarded to the lowest bidder, but NRHM reserves the right to reject any or, all the tenders without assigning any reason and to increase or decrease the number of vehicles to be engaged. If any dispute arise out of his contract, the same shall be referred to the State Mission Director, NRHM, Thiruvananthapuram, or any other officer nominated by him for the purpose, and his decision shall be final and binding and provision of law shall apply

IT returns for the last three years (Assesment year 2011-12, 2012-13 and 2013-14)
are to be submitted while submitting the pre qualification requirements. Non

submission will be liable for outright rejection of tender.

 Any other information required may be had from the Office of the State Mission Director (NRHM), NRHM Building, Directorate of Health Service, Thiruvananthapuram-695035, on all working days between 10.00 a.m to 5.00 p.m.

18. Vehicles of any other category needed on daily basis on casual duties as and when required should be provided by the Contractor on request from this office in time as per the agreed terms and conditions mentioned above.
