The sealed tenders should be addressed to the State Mission Director, Office of the State Mission Director, National Health Mission, Thiruvananthapuram, 695035 duly super scribing on the envelope as" Tender for purchase of unserviceable articles" and should reach this office on or before 16-07-2014 at 12.00 noon. The tenders will be opened on the same day after public auction in the presence of tenderers at the office of the undersigned.
2. The intending bidders submitting offers in sealed covers should furnish an earnest money deposit of Rs.2000 (Rupees Two thousand only) as Demand Draft from any scheduled bank drawn in favour of the State Mission Director, NHM, Kerala along with sealed tender.

The intending bidders participating in public auction should furnish an earnest money deposit of Rs.2000 (Rupees Two thousand only) as Demand Draft from any scheduled bank drawn in favour of the State Mission Director, NHM, Kerala before commencement of the public auction. The public auction will commence at the Office of the State Mission Director, SPMSU, National Health Mission, Thiruvananthapuram on 16.07.2014 at 03.00 PM .
4. The earnest money deposits of the unsuccessful tenderer will be refunded/returned on the same day soon after the completion of auction.
