GENERAL TERMS AND CONDITIONS:

1. A request application along with Bio data (including copy of all certificates) are to be submitted directly to NHM State office.
2. As directed in GO(Rt)No.2488/2021/H&FWD dated 10.11.2021, the preference for this recruitment will be for those candidates who were working in the COVID Brigade.
3. The selected candidate should be willing to travel anywhere in the State.

4. The applicants should be excellent in writing skills both in English and Malayalam and should be proficient in computers.
5. Selection will be based on qualification and experience in the event of there being more than one eligible applicant, an interview will be conducted.
6. The present offer of appointment will be UPTO 31.12.2021 only. This may be extended based on orders of Government of Kerala.
7. Appointment will be on daily wages basis only. Wages will be permissible only for those days on which the individual has worked for COVID Control activities.
8. Claims in respect of qualifications/ experience etc. should be supported by copies of relevant documents; candidates may be required to produce the originals at the time of interview. It will be ideal to provide reference, especially the names of superior officer, whom the candidate had worked in the previous organization(s).
9. No TA/DA will be paid for the interview.
10. All selected candidates will be governed by rules and regulations as prescribed from time to time.
