

### **Corrigendum**

Sub :- Tender for providing Toyota Innova crista Air Conditioned Car (Registered on or after 01-01-2021) for NHM SPMSU from competitive suppliers for the year 2024-2026 - reg

- I. The last date of submission of the tender document is extended **till 2 pm on 22.07.2024**. The opening of the tender will be at **3 pm on 22.07.2024**.
- II. The bidder shall attach a separate Demand Draft of Rs.1000/- (Rupees One thousand Only) as Cost of tender document from any Nationalized /Scheduled Bank in favour of the State Health & Family welfare society, payable at Thiruvananthapuram along with the tender document, failing which the offer will be rejected. MSME Udyam registered firms are exempted from tender fee as per order No. GO(P) No. 2/2019/SPD Dated 24-01-2019.
- III. **Earnest Money Deposit (EMD) :**
  - a. An amount of Rs.5000/-(Rupees five thousand only) should be submitted along with the tender as bid security (EMD) in the form of DD in favour of State Health & Family Welfare Society, payable at Thiruvananthapuram. Non- submission of sufficient EMD as mentioned shall be one of the primary reasons for rejection of the bid. MSME Udyam registered firms are exempted from EMD as per order No. GO(P) No. 2/2019/SPD Dated 24-01-2019.
  - b. Cheque, Money Order, Fixed deposit etc will not be accepted as EMD.
  - c. EMD of unsuccessful bidders will be discharged/returned as promptly as possible but not later than 30 days after opening of the bids by the tender Inviting Authority.
  - d. The successful bidder's EMD will be converted into performance security for the contract.
  - e. No interest will be paid for the EMD submitted.
  - f. The EMD will be forfeited, if a bidder:-
    - i. misrepresents facts or submits false/fake documents during the tender process
    - ii. if the bidder wilfully violates any terms and conditions of the tender documents
    - iii. withdraws bid after the opening of bid;
    - iv. a successful bidder, fails to sign the contract.

THOSE WHO HAVE ALREADY SUBMITTED THE TENDER SHALL SUBMIT THE COST OF THE TENDER DOCUMENT ( RS. 1000) AS WELL AS EMD ( Rs.5000/-) (WHEREVER APPLICABLE) IN A SEPARATE COVER ON OR BEFORE **2 pm on 22.07.2024**. THE TENDER OF THE BIDDERS WHO FAIL TO SUBMIT THE AFORESAID DOCUMENTS WILL NOT BE CONSIDERED.
