<u>Specification and condition for Hiring of Boat for Valanthakad Floating Dispensary on Contract Basis</u>

Competitive e- tenders are invited for hiring of boat for floating dispensary for Valanthakad based on contract basis, under the following terms and conditions:

- 1. The boat will have to run distance as required directed
- 2. The boat along with driver shall be provided from 8.00am to 5.00pm on all working days. Sundays and eligible holidays are exempted
- 3. All the maintenance of the boat will have to be done by the contractor/owner.
- 4. The rate for each category of boat contracted on monthly basis.
- 5. Fuel for the boat will have to be provided by the contractor/owner.
- 6. No Seprate bata for drivers will be given even for outstation duties.
- 7. The initial contract shall be signed for 6 months which can be extended further based on need of the society & also satisfactory performance of the hired boat.
- 8. Drivers for out station duties have to make their own stay arrangements.
- 9. NHM reserves the right to terminate the deal without assigning any reason
- 10. In case of dire emergencies / Natural Calamities/ mass casualty which may occur on extempted days, the owner should provide the service of the boat without fail for which dailyallowance will be provided.
- 11. All expenses related with boat should be met by the contractor/owner.

Specifications of the boat

- 1. The boat should be more than 40 feet long and 12 tonnage of capacity.
- 2. There should be two cabins
- 3. There should wash base in the boat
- 4. There should be dressing table and medicine tray
- 5. In addition to the driver, one helper to be present in the boat for the smooth functioning of the floating dispensary
- 6. Boat should have toilet facility
- 7. The owner should provide Drinking water facility for staff in the boat

Conditions for monthly Basis

- 1. The rate quoted should include wages to the boat crew, maintenance charges, monthly fuel charges or and any other charges for providing boat in a good running condition.
- 2. The boat should be parked at the specified boat jetty on all days
- 3. The boat should have the recognition of Chief Inspector of Boats
- 4. The crew should have valid license.
- 5. The boat should have all safety measures
- 6. The boat should have a valid fitness certificate from Kerala port with complete lifesaving equipments as per KIV rules.
- 7. In case of non availability of boat on demand at any time penalty per day is liable to be imposed of an amount equivalent to the rates approved for concerned category on daily basis.
- 8. In case of non –provision of boat continuously for a period more than three days,it shall be treated as breach of contract, and the EMD shall be forfeited. EMD is also liable to be forfeited if the contractor is not prepared to provide the boat after awarding the contract to him.

- 1. The Bidder should pay tender fees as Mentioned above.
- 2. Bidder should deposit an Earnest money Deposit (EMD) As mentioned above.
- 3. A 5%of the accepted contact rate (for 6 months) should be remitted as security deposit on receipt of the worker order. The security deposit will be refunded after the completion of the contract period.
- 4. The E- tenders prepared in the prescribed format should be uploaded in the website before **02.00 pm**, **05.08.2025**. The tenders will be opened on 06.08.2025, 02.00 p,m.lf for any reason on **06.08.2025**, **02.00 p.m** become a holiday the opening date of the tender will sueomoto stand schedule in the next working day.
- 5. Tender form and other documents will be available from the e- Tender portal www.etenders.kerala.gov.in up to the last date of submission of e-Tender.
- 6. e-Tender prepared in the prescribed format (BOQ) should submit in the e- Tender website www.etenders.kerala.gov.in before the last date of submission of e-Tender.
- 7. The rate should be guoted in Indian Rupees. The rates must be inclusive of taxes.
- 8. The Contractor shall provide and keep the boat in good running condition and all taxes; insurance etc. shall be paid and borne by him. The boat, when contracted, will be kept at the disposal of the NHM. If and when the driver is not available, if required, may be operated by any one as nominated by NHM.
- 9. Whenever the boat is taken for service, an alternate boat of the similar category will have to provide by the contractor at his own cost within a reasonable time.
- 10. In the case of an accident while the boat is being driven by the contractor's driver, all repairs shall be done by the contractor without any liability to NHM or its employees. In case, due to some breakdown, the boat is not available, the contractor shall make arrangements to provide alternate boat at his own coast, within a responsible time.
- 11. Rates terms and conditions of contract quoted, once accepted by NHM shall not be altered during the currency of the contract (normally 6 months) for any reason and shall be valid till the expiry of contract, for 6 months from the date of award. There shall not be any price increase in the the rates quoted during the currency of the contract. The contract can be terminated by giving a notice of one month on either side.
- 12. The payment will be made only on a monthly basis on presentation of report form charge Medical Officer after deducting statutory recoveries
- 13. The contract will be normally for six months from the date on which the boat start playing and the tenders should execute an agreement with NHM to that effect in a stamped paper worth Rs.200/-
- 14. The driver should be well dressed, well behaved and professional skilled to drive any make of boat .Any laxity of the behaviour of the Drivers shall be treated as breach of contract resulting in cancellation of contract and forfeiture of EMD
- 15. The tender should be sent only on online . Please see the site www.etenders.gov.in
- 16. No advance will be made and the payment will be made only on a monthly basis on

- presentation of bill after deducting statutory recoveries.
- 17. If the service of the contractor are not satisfactory,NHM reserves the right to cancel the contract at any point of time without giving any reasons thereof.
- 18. In case of non availability of the boat on any day the expenses incurred by this office in this regard for making alternate arrangements, will be deducted from the contractor from his monthly hire charges payable to him by the company / from his security deposit
- 19. In case of non provision of boat continuously for a period of more than three days or failure to attend repairs and replacement promptly to our satisfaction, it shall be treated as breach of contract, and the EMD shall be forfeited and contract may not be continued any further.
- 20. Term and conditions of contract quoted and accepted by the District Programme Management Unit shall not be altered during the contract Period.
- 21. Normally, the contract will be awarded to the lowest tenderer, but NHM reserves the right to reject any or all the tenders without assigning any reason and to increase or decrease the number of boat to be engaged. If any dispute arise out his contract, the same shall be reffered to the State Mission Director, NHM, Thiruvananthapuram, or any other officer nominated by him for the purpose, and his decision shall be final and binding and provision of law relating to arbitration for the time being shall apply to such arbitration.
- 22. Any other information required may be had from the office of the District Programme Manager, No.9,Anchorage,Palliyil Lane,Ernakulam on all working days between 10.00 am to 5.00 pm. Ph: 0484-2354737
