4. The successful bidders are requested to submit an agreement in stamped paper worth Rs. 200/- as per store purchase rules. The Tenders must be submitted by the applicable amount of Taxes as per rules.
5. Those firms who have MSME/Rate Contract Agreement with Government should submit relevant copies of Government orders along with the tender form itself.(MSME firms are exempted for Tender fee and EMD).
